2) **GRIDCo now** invites sealed Tenders from eligible Cleaning Service Providers for the provision of Cleaning Services in its operational areas namely Accra, Tema, Kumasi, Tamale, Akosombo, Tafo Sub Area, Takoradi, Prestea, Techiman and Bolgatanga.

Prospective Bidders would be allowed to bid for only one lot. The eligibility criterion is that, Interested Tenderers must be located in the Operational Area and show evidence of Business location. Bids submitted will be evaluated individually for every Area, and only one contract awarded to the most qualified Tenderer in the Lot in that Area. Contracts shall be awarded separately for each Lot.

- 3) Tendering will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Act, 2003 (Act 663) and Amended Public Procurement Act, 2016 (Act 914) and in the Guidelines of the Public Procurement Authority of the Republic Ghana.

Late Tenders will be rejected. Electronic Tendering is not permitted.
