7. Tenders shall be completed, sealed and marked **“Design, Supply, Installation and Commissioning of Uninterruptible Power Supply (UPS) System, Surge Protection Device (SPD) and Automatic Voltage Stabilizer and Minor Civil Works.”** and delivered to the address below.

Tenders shall be valid up to **180 days** after the deadline of Tender submission. All Tenders must be accompanied by a Tender Security/Tender Bond of **Ten Thousand Ghana Cedis (GH¢10,000.00)** and in the appropriate form and format included in the Tendering Document.

Late Tenders will be rejected. Electronic Tendering is not permitted.
