The West African Power Pool (WAPP) Secretariat, a Specialized Institution of the Economic Community of West African States (ECOWAS), headquartered in Cotonou, Republic of Benin, has received a Grant from the World Bank, and applied for a grant from the "Agence Française de Développement" (AFD) and the NEPAD Infrastructure Project Preparation Facility (NEPAD-IPPF), and intends to apply part of the proceeds for consulting services.

The Consulting services ("the Services") include an update of the Pre-investment Studies including a Line Route Study, an Environmental and Social Impact Assessment (ESIA), a Resettlement Action Plan (RAP), a Feasibility Study, and preparation of associated functional EPC Bidding Documents of Ghana – Burkina – Mali Interconnection Project.

The project involves the construction of approximately 566 km of high voltage double circuit transmission line from Bolgatanga in Ghana to Sikasso in Mali passing through Bobo Dioulasso in Burkina.

The overall objective of the assignment is to undertake among others:

a) Line Route Study and Substation Site Selection:

- Study of line route
- Detailed survey and profiling of line route
- Identification of substation sites (creation and/or extension)
- Detailed survey of substation sites and road access
- Preparation of relevant maps and drawings.

b) LIDAR Survey

c) Environmental and Social Impact Assessments (ESIAs):

- Preparation of Stakeholder Engagement Plan (SEP) for Ghana, Burkina Faso and Mali
- Preparation of Environmental and Social Impact Assessments (ESIAs) for Ghana, Burkina Faso and Mali
- Preparation of Resettlement Action Plans (RAPs) for Ghana, Burkina Faso and Mali
- Preparation of Illustrative Materials for Ghana, Burkina Faso and Mali
- Public Information and Sensitization Campaign for Ghana, Burkina Faso and Mali
- Environmental and Social Management Framework (ESMF) and Resettlement Policy Framework (RPF) in compliance with World Bank ESF and applicable Environmental, Health and Safety Guidelines and Guidelines and Policies of other donors for the Electrification of Communities/Towns/Villages Along Line Route and Around Substations for Ghana, Burkina Faso and Mali

d) Feasibility Study Including Technical, Financial and Economic Analyses

- A technical study on the interconnection including required network reinforcements and electrification component
- Economic and financial analyses including sensitivity analyses and a tariff proposal

e) Risk analyses

- f) Training and Capacity Building Program
- g) Project Packaging and Preparation of Pre-qualification if required and Functional Bidding Documents for EPC contracts
- h) Preparation of Terms of Reference of Owner's Engineer for Supervision of the Project.

The implementation period is estimated at 82 weeks. The expected start date of the assignment is September 2021.

Interested Consultants should note that selected candidate will be required to put in place "Chinese Wall" type conditions that will foster balanced and fully independent views between technical aspects on the one hand and environmental and social aspects on the other hand, as well as prevent any conflict of interest. These conditions shall include among others (i) full independence of the two teams (technical, and environmental & social); (ii) each team manages, prepares, and validates their specific deliverables independently; and (iii) if deemed required, mobilization of neutral/balanced overall coordination, independent from the two teams. The two teams are nevertheless still required to work in close collaboration and share core data in order to ensure coherence and consistency of all deliverables.

The West African Power Pool (WAPP) Secretariat now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. **The shortlisting criteria are**:

- 1. Relevant experiences and competences in the preparation (Feasibility study, network studies, conceptual design, etc.) of Electricity High Voltage Interconnection Projects;
- 2. Relevant experiences and competencies in line route studies of high voltage (at least 220 kV) cross-border interconnection projects covering at least two countries in Sub Saharan Africa;
- 3. Relevant experiences and competences in the preparation of Environmental and Social Impact Assessments (ESIAs) Studies, Preparation of Resettlement Action Plans and in the preparation of Environmental & Social Management Plans with measures addressing SEA/SH and vulnerable groups. Experiences with High Voltage Transmission Lines shall be considered an asset.

Key Experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's *Guidelines:*Selection and Employment of Consultants by World Bank Borrowers (January 2011- Revised July 2014) ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the "Quality and Cost-based Selection" method set out in the Consultant Guidelines.
